QUESTION ONE

- (a) Kiongozi Advisory LLP prepares board reports using competitor prices, customer-retention data, supplier-risk indices and long-term sustainability indicators. The partner in charge is concerned that strategic management accounting information could be manipulated or disclosed selectively during capital allocation discussions. In relation to this scenario, evaluate **THREE** governance and ethical safeguards that should be applied before the information is used by the board. (6 marks)
- (b) AfriScan Diagnostics Ltd. operates mobile diagnostic units for corporate medical-screening contracts. The management wants to price a new regional contract using a regression-based cost model. The commercial director is concerned that the model may understate the cost of remote routes where emergency maintenance and travel disruptions are common.

Additional information:

1. Monthly operating cost is measured in Sh. million.
2. The estimated regression model is: $Y = 2.750 + 0.480X_1 + 1.600X_2 + 0.022X_3$, where X_1 is kilometres travelled in thousands of kilometres, X_2 is screening tests in thousands of tests and X_3 is emergency maintenance hours.
3. The regression was estimated from 24 monthly observations.
4. The regression output is as follows:
5. R-squared is 0.88; adjusted R-squared is 0.86; F-statistic is 45.20 with p-value <0.001.
6. Variance inflation factors are: kilometres travelled 1.9, screening tests 2.4 and emergency maintenance hours 6.8.
7. The Durbin-Watson statistic is 1.14; a value materially below 1.50 indicates possible positive serial correlation.
8. For the proposed contract, expected monthly activity is 26,000 kilometres, 13,200 screening tests and 90 emergency maintenance hours.
9. A reliability surcharge of 10% is added to estimated operating cost because service interruptions attract penalties.
10. The required operating margin is 20% of the final contract price.

Required:

- (i) Calculate the predicted monthly operating cost and determine the minimum monthly contract price after incorporating the reliability surcharge and required margin. (6 marks)
- (ii) Interpret the significance, economic plausibility and reliability of the regression output for contract pricing. (6 marks)
- (iii) Recommend **TWO** managerial actions before relying on the model for remote-route bids. (2 marks)

QUESTION TWO

- (a) Nuru Millers Ltd. has discovered that waste grain, rework, off-specification flour and disposal costs are hidden within general factory overheads. In relation to this situation, analyse **TWO** ways in which flow cost accounting could improve environmental cost visibility and control. (4 marks)
- (b) Mtiro Components Ltd. manufactures three filtration products using the same coating chamber, which is the bottleneck resource. The sales manager has received a special export order that could displace normal production. Management requires a decision that protects contribution, bottleneck utilisation and long-term customer relationships. For decision purposes, products should be ranked by contribution per coating chamber minute after deducting all variable costs. Reputational penalties should be considered only where normal demand is displaced or remains unmet.

Additional information:

1. Normal monthly demand, selling prices and variable costs are as follows:

Product	Demand (units)	Selling price per unit Sh.	Direct material per unit Sh.	Other variable cost per unit Sh.
Kingo	12,000	1,850	790	410
Lumo	9,000	2,400	1,050	530
Safi	7,000	3,200	1,410	840

2. Coating chamber minutes required per unit are Kingo 6 minutes, Lumo 9 minutes and Safi 14 minutes.
3. Available coating chamber time for the month is 184,500 minutes.
4. Fixed production cost attributable to the product range is Sh.18,500,000 per month and is unavoidable in the short term.
5. A regional distributor has offered to buy 3,500 additional units of Lumo at Sh.2,050 each.
6. The special order requires the same coating time as normal Lumo units, a special export inspection cost of Sh.85 per unit and additional documentation cost of Sh.650,000 in total.
7. If normal demand is not met, reputational penalties are estimated at Sh.120 per unit of unmet demand for Kingo, Sh.180 for Lumo and Sh.300 for Safi.
8. Management wants the recommendation to consider the incremental financial effect, reputational penalties and future market access.

Required:

- (i) Determine the optimal monthly production plan before considering the special export order using contribution per coating chamber minute. (5 marks)
- (ii) Calculate the incremental financial effect of accepting the special export order after allowing for displaced normal production and reputational penalty. (5 marks)
- (iii) Recommend whether the special export order should be accepted after considering the financial effect and future market access. (4 marks)
- (iv) Explain **TWO** qualitative factors that could alter the recommendation in (b) (iii) above. (2 marks)

QUESTION THREE

- (a) Nyota Appliances Ltd. intends to launch a connected cooker in a price-sensitive regional market. The marketing team prefers value-based pricing while the production team prefers full cost-plus pricing. In the context of this product launch, evaluate **TWO** strategic risks of relying mainly on full cost-plus pricing. (4 marks)
- (b) Jasiri Guest Services Ltd. manages serviced apartments through three customer channels. The general manager is negotiating a renewal contract with online agents after complaints that headline room-night volume hides the real cost of booking changes, service recovery and loyalty administration. The board requires customer-channel performance measures that balance profitability, service quality, innovation and flexibility.

Additional information:

Corporate accounts	8,000	8,200	4,600
Online agents	5,000	7,400	5,900
Walk-in guests	3,000	6,900	5,100

1. Customer-support activity costs for the year ending 31 December 2026 are as follows:

Booking changes	Number of changes	4,200,000	600	1,200	400

2. The board requires each customer channel to earn at least a 12% profit margin on revenue after assigning customer-support activity costs.
3. The online-agent contract is expected to generate the same 5,000 room nights next year unless the price is increased beyond market tolerance.

Required:

- (i) Calculate the customer-channel profit before and after allocating customer-support activity costs using activity-based customer profitability analysis. (8 marks)
- (ii) Determine the minimum average revenue per room night required from online agents to achieve the board's 12% profit-margin target. (4 marks)
- (iii) Assess **TWO** Fitzgerald and Moon performance standards, such as ownership, achievability or equity, that Jasiri Guest Services Ltd. should apply when evaluating the online-agent renewal contract. (4 marks)
- (Total: 20 marks)**

QUESTION FOUR

- (a) Bahari Components Ltd. uses annual incremental budgets despite frequent changes in customer orders and production technology. In relation to this environment, summarise **TWO** benefits of feed-forward and rolling budgetary controls. (4 marks)
- (b) Kazi Medical Kits Ltd. is preparing a material requirement plan for component pack CP-7, which is used in assembling emergency medical kits for institutional buyers. Hospital orders are revised frequently, but the production manager must maintain a minimum closing inventory reserve while avoiding unnecessary purchases.

Additional information:

- Each emergency medical kit requires 3 units of component pack CP-7.
- Opening inventory of CP-7 at the start of Week 1 is 3,300 units.
- A scheduled receipt of 1,800 units is due in Week 2.
- A minimum closing inventory reserve of 600 units must be maintained at the end of each week.
- Orders are placed using lot-for-lot ordering.
- The lead time for CP-7 is one week.
- The master production schedule for emergency medical kits is as follows:

Week	1	2	3	4	5	6
Master production schedule for kits (units)	900	1,100	1,200	1,000	1,300	1,400

Required:

Prepare a material requirement plan for CP-7 for Weeks 1 to 6, showing gross requirements, scheduled receipts, projected inventory, planned order receipts and planned order releases. (8 marks)

- (c) Pamba Devices Ltd. uses ex-post standards to separate planning variances from operational variances after a technology change affected labour time and labour rates. The production director wants supervisors assessed fairly, but avoidable inefficiencies must still be investigated.

Additional information:

1. Original budget: 10,000 units requiring 5,000 labour hours at Sh.1,200 per hour.
2. Actual output was 11,500 units; actual labour hours were 6,200 at a total cost of Sh.7,130,000.
3. Revised ex-post standard: 0.45 hours per unit at Sh.1,100 per hour.
4. Management estimates that investigating the adverse pattern will cost Sh.280,000.
5. Corrective action is expected to save Sh.720,000 next quarter if the variance pattern is controllable; the probability that it is controllable is 0.60.

Required:

- (i) Calculate the planning variance and the operational variance for total direct labour cost. (4 marks)
- (ii) Decompose the operational variance into labour rate and labour efficiency components using the revised standard. (2 marks)
- (iii) Advise whether the adverse variance pattern should be investigated using the expected-value investigation model. (2 marks)

QUESTION FIVE

- (a) Zawadi Pack Ltd. faces volatile input prices, rising waste-disposal charges and frequent machine changeovers. The finance director wants environmental costs to influence product pricing and product-mix decisions rather than remain hidden in general overheads. In relation to this operating environment, evaluate **TWO** strategic implications of making environmental costs visible for pricing and product-mix decisions. (4 marks)
- (b) Mapato BioChem Ltd. produces two biodegradable cleaning products: PureA and PureB. The company is introducing environmental activity-based costing to improve the visibility of environmental costs and to support strategic product-mix and pricing decisions. The board also wants to understand whether recognising environmental costs changes the division's value creation.

Additional information:

1. The processing division reported operating profit of Sh.140,000,000 before recognising the environmental costs shown below. The listed environmental costs are incremental and have not been included in the reported profit.
2. Capital employed in the processing division is Sh.620,000,000.
3. The company's weighted average cost of capital is 12%.
4. For economic value-added purposes, ignore taxation.
5. Environmental cost pools and drivers are as follows:

Environmental cost pool	Cost driver	Total cost Sh.
Waste-water treatment	Effluent litres	36,000,000
Emissions monitoring	Machine hours	12,000,000
Hazardous waste disposal	Hazardous waste kilograms	18,000,000

6. Activity-driver usage by product line is as follows:

Effluent litres	240,000	360,000	600,000
Machine hours	18,000	12,000	30,000
Hazardous waste kilograms	20,000	70,000	90,000

Required:

- (i) Allocate the environmental costs to PureA and PureB using environmental activity-based costing. (7 marks)
- (ii) Calculate the division's economic value added before and after recognising the environmental costs. (4 marks)
- (iii) Evaluate how environmental activity-based costing and economic value added could jointly improve strategic performance management, pricing and product-mix decisions at Mapato BioChem Ltd. (5 marks)

QUESTION ONE

- (a) Evaluate **THREE** ways in which environmental management accounting can support strategic investment appraisal under regulatory uncertainty for the board. (6 marks)
- (b) Mambo Ltd. manufactures industrial packaging materials for export markets and faces increasing sustainability reporting obligations and possible carbon border adjustment taxes. Failure to proactively manage environmental costs may weaken long-term competitiveness and restrict access to environmentally sensitive markets.

The board is considering investing in a low-emission production facility to reposition the company strategically and mitigate future regulatory exposure. However, projected cash inflows depend on the regulatory environment that will prevail over the next five years.

Additional information:

1. Initial investment required is Sh.72,000,000.
2. Project life is five years with no residual value.
3. Cost of capital is 11%.
4. If strict carbon taxation is introduced (probability 0.4), annual net cash inflows will be Sh.28,000,000.
5. If moderate regulation applies (probability 0.35), annual net cash inflows will be Sh.18,000,000.
6. If no regulation is enacted (probability 0.25), annual net cash inflows will be Sh.9,000,000.
7. Present value of annuity factor for five years at 11% is 3.696.

Required:

- (i) Calculate the expected net present value (ENPV). (6 marks)
- (ii) Assess whether the project should be undertaken from both a financial and strategic perspective. (8 marks)
- (Total: 20 marks)**

QUESTION TWO

- (a) Summarise **THREE** strategic implications of implementing a just-in-time inventory system in an organisation operating under demand volatility and supplier lead-time uncertainty. (6 marks)
- (b) Uwezo Equipment Ltd. assembles precision irrigation systems. The firm's customer contracts require high service reliability, but the company experiences fluctuating demand driven by seasonal farming patterns and project-based procurement.

A critical component is imported, and supplier lead times are affected by shipping delays. Management is reviewing its ordering policy in order to minimise total relevant inventory cost while maintaining the required service level. A supplier has proposed a quantity discount, although accepting the discount would result in larger average inventories.

Assume that:

- Annual demand is known and constant for Economic Order Quantity (EOQ) purposes.
- Lead time is constant at four weeks.
- Demand during lead time is normally distributed.
- Safety stock is held only to achieve the required cycle-service level.

Additional information:

1. Annual demand is 80,000 units.
2. Ordering cost is Sh.4,000 per order.
3. Annual holding cost is Sh.180 per unit.
4. Purchase price is Sh.2,000 per unit.
5. A supplier offers a 5% discount for orders of 6,000 units or more.
6. Weekly demand standard deviation is 150 units.
7. Lead time is 4 weeks.
8. Desired service level is 97% ($Z = 1.88$).
9. There are 50 working weeks per year.

Required:

- (i) Compute the economic order quantity (EOQ). (3 marks)
- (ii) Calculate the total annual relevant cost under the EOQ policy and under the discount policy based on an order quantity of 6,000 units. In each case, include annual purchase cost, annual ordering cost and annual holding cost. Hence, advise management on whether the quantity discount should be accepted. (7 marks)
- (iii) Using the standard deviation of demand during lead time derived from the weekly demand variability given above, compute the safety stock and the re-order level required to achieve the stated service level. (3 marks)
- (iv) Explain **ONE** limitation of applying the EOQ and service level-based safety stock model in this context. (1 mark)

QUESTION THREE

- (a) Explain **TWO** measures commonly used to assess investment centres in a decentralised organisation, showing how each might influence managerial behaviour. (4 marks)
- (b) Bora Ltd. operates Processing and Distribution divisions, both of which are treated as investment centres within a decentralised structure.

The Processing division manufactures an intermediate product that may either be sold to external customers or transferred internally to the Distribution division. The senior management is concerned that an inappropriate transfer price may encourage divisional managers to optimise divisional performance at the expense of overall company profitability.

Additional information:

1. The external market can absorb any output not transferred internally and the external market price is constant.
2. The Processing division has sufficient capacity to satisfy the Distribution division's requirement.
3. All units transferred internally are processed and sold by the Distribution division in the same year.
4. The processing capacity is 600,000 units per annum.
5. The external selling price of the intermediate product is Sh.120 per unit.
6. The variable cost in processing is Sh.70 per unit while the annual fixed costs amount to Sh.30,000,000.
7. The Distribution division requires 400,000 units per annum.
8. Final selling price by Distribution is Sh.200 per unit.
9. Additional variable cost in Distribution is Sh.45 per unit.
10. Average operating assets of Processing are Sh.150,000,000.
11. For purposes of performance evaluation, in part (iii) divisional operating profits should be taken as divisional contribution less traceable fixed costs.
12. Required rate of return is 16%.

Required:

- (i) Determine the minimum transfer price and the maximum transfer price per unit. (4 marks)
- (ii) Assuming that the transfer price is set at the external market price, prepare in columnar form divisional operating statements for the Processing division, the Distribution division and the company as a whole. Comment on whether the resulting transfer price promotes goal congruence. (6 marks)
- (iii) Using the market-price transfer assumption in part (b) (ii), calculate for the Processing division's Return on investment (ROI) and Residual income (RI). Critically assess which of the two measures provides a more appropriate basis for performance evaluation in this case. (6 marks)

- (a) Discuss **TWO** strategic benefits of integrating life cycle costing with target costing in the development of a technologically advanced product. (4 marks)
- (b) Gari Motors Ltd. is developing a new electric commercial vehicle in response to tightening emission standards and increased fuel prices. Market research indicates significant price sensitivity and aggressive competitive entry within the next year. Management has adopted a target costing approach supported by learning curve analysis to ensure the product achieves its required profitability at launch. Since the assembly process involves new tooling and workforce training, labour efficiency is expected to improve during the early production stages.

Additional information:

1. Target selling price is Sh.14,000,000.
2. Target profit margin is 22% of selling price.
3. First unit requires 220 labour hours.
4. Direct labour rate is Sh.16,000 per hour.
5. Direct material cost per unit is Sh.5,000,000.
6. Variable production overhead is absorbed at Sh.5,000 per direct labour hour.
7. Fixed production overhead specifically attributable to the first eight units is budgeted at Sh.18,000,000 in total and is to be absorbed evenly over those eight units.
8. An 85% learning curve applies for the first eight units.
9. Learning index is -0.234 .

Required:

- (i) Calculate the target cost per unit. (3 marks)
- (ii) Estimate the average labour time per unit for the first eight units and its implication for early-stage production planning. (5 marks)
- (iii) Determine the expected average total cost per unit for the first eight units. (4 marks)
- (iv) Evaluate the cost gap and recommend strategic actions management should prioritise before market launch. (4 marks)

- (a) Describe **FOUR** stages involved in applying advanced budgetary control techniques in an organisation operating under high demand uncertainty and significant operational risk. (8 marks)
- (b) Upishi Events Ltd. has secured an exclusive catering contract for a national outdoor festival. Management must decide in advance the number of premium food packages to prepare. Unsold packages will have no resale value after the event.

Based on historical patterns, the management estimates the following probabilities:

- Low demand: 0.3
- Moderate demand: 0.4
- High demand: 0.3

Estimated profit outcomes (Sh.) are shown below:

Demand condition	3,000 units	4,000 units	5,000 units	6,000 units
Low	4,000	2,000	(3,000)	(6,000)
Moderate	6,000	9,000	11,000	8,000
High	8,000	12,000	16,000	20,000

Required:

- (i) Determine the optimal decision using the Maximin and Maximax criteria. (4 marks)
- (ii) Calculate the expected monetary value (EMV) for each decision alternative and identify the optimal decision. (4 marks)
- (iii) Computing the expected value of perfect information (EVPI), advise whether obtaining perfect demand information would be justified in principle. (4 marks)

QUESTION ONE

- (a) Explain **THREE** limitations of just-in-time (JIT) inventory system. (6 marks)
- (b) Kisasa Electronics Ltd. manufactures cameras and video equipment for high-end users. The company uses life cycle costing and target costing principles to produce the world's smallest and lightest camcorder with superior recording capabilities.

The following summary of the information has been presented by the management accountant:

1. Projected life cycle sales volume 3,000 units
2. Target selling price per unit Sh.8,000
3. Target profit margin 30%
4. Projected total cost based on linear regression analysis on product life cycle in present value terms are as follows:

Cost object	Cost behaviour
Research and development costs:	$Y = 3,000,000 + 300X$
Design phase costs:	$Y = 2,500,000 + 250X$
Production expenses per unit:	$Y = 1,610X$
Marketing and advertisement expenses:	$Y = 980,000 + 20X$
Distribution and delivery overheads	$Y = 1,000,000 + 100X$
Customer care service costs:	$Y = 1,205,000 + 375X$

Where: Y - Total actual cost
X - Projected life cycle sales volume in units

Required:

Using target costing approach, compute unit cost gap for the product. (6 marks)

- (c) Junction Cafeteria buys and sells hot take-away food. The cafeteria wants to decide on how many burgers to purchase for sale at a forthcoming outdoor concert. The number of burgers sold will depend on the weather conditions and any unsold burgers will be thrown away at the end of the day.

There is a 30% chance that the weather will be good, a 20% chance that the weather will be normal and a 50% chance that the weather will be bad.

The table below details the profit that would be earned for each possible outcome:

Weather	Number of burgers purchased			
	1,000 Sh.	2,000 Sh.	3,000 Sh.	4,000 Sh.
Bad	1,000	0	(1,000)	(3,000)
Normal	3,000	6,000	7,000	6,000
Good	3,000	6,000	9,000	12,000

The number of burgers to purchase to satisfy:

- (i) Maximin criterion. (2 marks)
- (ii) Maximax criterion. (2 marks)
- (iii) Minimax criterion. (4 marks)

QUESTION TWO

- (a) The Management Accountant should carry out risk assessment and disaster preparedness when accounting for environmental costs. This is as a result of the dynamic environmental changes and government compliance requirements.

Required:

Analyse **THREE** interventions to implement and to take to minimise the impact of dynamic environmental risks and internal failure costs. (6 marks)

- (b) One of the functions of the Management Accountant is to generate confidential reports for strategic internal decision making. However, most of these reports are flawed with integrity issues such as conflict of interest, creative accounting and lack of credibility.

Required:

With reference to Strategic Management Accounting Information, explain the meaning of the following Ethical Standards for Management Accountants:

- (i) Confidentiality. (1 mark)
 - (ii) Integrity. (1 mark)
- (c) Jikoni Ltd. is a manufacturer of edible vegetable oil branded “Soya oil”. The company uses three basic ingredients to make Soya oil. The standard data for a litre of “Soya oil” is as follows:

Standard cost per unit of “Soya oil”

Ingredients	Standard mix ratio	Standard price per litre (Sh.)
Alpha	50%	70
Beta	30%	50
Zeta	20%	20

A standard loss of 10% is expected in production. During the month of March 2025, the actual output was 92,700 litres of “Soya oil”.

The actual quantities mixed and actual cost data were as follows:

Calculate the following cost variances:

- (i) Material price variance. (3 marks)
- (ii) Material usage variance. (3 marks)
- (iii) Material mix variance. (3 marks)
- (iv) Material yield variance. (3 marks)

QUESTION THREE

- (a) The balanced Scorecard Model is an integrated model that combines both financial and non-financial performance measures of performance as opposed to conventional measures that focus only on quantitative financial performance measures.

With reference to the above statement, discuss **TWO** challenges you might encounter while analysing Public Sector performance using non-financial measures of performance. (4 marks)

- (b) Tulia Ltd. is the leading manufacturer and distributor of executive mattresses in the country. The mattresses differ in size, quality and class of customers. The company is in the process of preparing its activity-based budget (ABB) for its main three types of mattresses. These are family, luxury and standard.

The following budgeted information is available for the budget period:

Type of mattress	Family	Luxury	Standard
Current sales-mix	25%	40%	35%
Units produced and sold	1,250 units	2,000 units	1,750 units
	“Sh. per unit”	“Sh. per unit”	“Sh. per unit”
Selling price per mattress	10,000	12,050	8,750
Direct material (Sh.250 per kg)	2,500	4,000	1,750
Direct labour (Sh.500 per labour hour)	1,500	1,750	1,250

The total number of activities for each of the three types of mattresses for the period is as follows:

Fixed overhead costs have been analysed as follows:

Additional information:

- The total budgeted fixed overhead costs for the budget period are Sh.21,717,000.
- The direct labour force is threatening to go on strike for two weeks out of the coming four weeks. This means that direct labour hours will be limited to 7,975 hours for production rather than the budgeted 15,950 hours.
- The total overhead costs for the month of January 2026 have only been analysed into three cost drivers. The activity-based budgeting (ABB) will not be affected by the limitation in labour force strike.

QUESTION ONE

- (a) “Resilience” describes the capacity or ability of an organisation to anticipate and mitigate environmental risks and costs and recover from their adverse effects in a timely and efficient manner. This is because the external environment has a significant impact on the business activities and financial performance of an organisation.

With reference to environmental management accounting (EMA), identify **THREE** countermeasures that each of the following techniques could provide to build resilience and adaptation to environmental cost identification and allocation:

- (i) Environmental life cycle costing. (3 marks)
- (ii) Environmental inflow-outflow analysis. (3 marks)
- (b) With reference to decision making criteria under uncertainty, explain the meaning of the following decision criteria:
- (i) Minimax criterion. (2 marks)
- (ii) Maximin criterion. (2 marks)
- (c) Optima Gas Limited has two divisions; Beta division and Optima division which operate as profit centres. Beta division makes a component known as “token metre” which is a prepaid “pay as you use” token device used by Optima division to make “Optima Gas Cylinder” to optimise digital payment. Prior to Beta division being established, Optima division outsourced the component on the external market at a price of Sh.1,600 per token metre.

Beta division has an external market for the “token metre” and also transfers to Optima division. Optima division uses one “token metre” to produce a gas cylinder which is sold externally. There are no other products produced and sold by these divisions. The forecast annual sales, associated costs and capacity level for the divisions are as follows:

- (b) Plasma Electronics Ltd. supplies digital decoders and Liquid Electronic Display (LED) television sets for high end users. Customers contract Plasma Electronics Ltd. with requests for maintenance of their terrestrial signal frequency. To estimate the service cost, Plasma Electronic Ltd. wish to predict their installation time in hours (the dependent variable) necessary for each maintenance request.

Installation time is believed to be related to two factors; the number of months since the last maintenance services and the type of maintenance problem, whether digital or analogue.

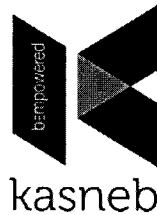

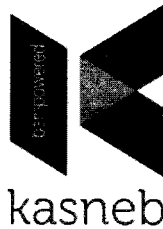

- There is a recommendation by the Managing Director (MD) that applying the economic order quantity (EOQ) model is the only optimal way of improving the stock holding policy. The company's annual demand is estimated to be 432,000 litres which the MD assumes to be evenly distributed over 330 working days in a year. The cost of delivery is estimated to be Sh. 6,000 per order and the annual variable holding cost per litre at Sh. 2.4 plus 1% of the purchase price. The company's policy is to order 20,000 litres each time and the lead time for an order is 3 working days.

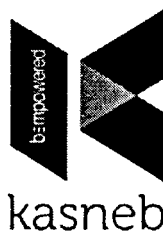

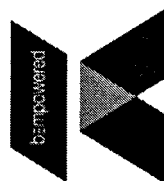

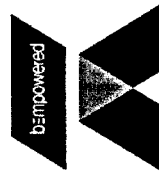

- The returns of each investment of a division is determined using the following formula:

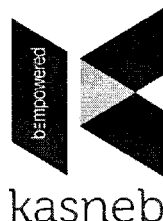
$$\text{Return} = \text{Divisional revenues (sales to outsiders and insiders)} - \text{direct divisional costs} - \text{allocated central corporate costs}$$
- The investment of a division is determined as follows:

$$\text{Investment} = \text{Book value of assets}$$
- Book value of assets is the aggregate of the accounts receivable net of accounts payable, inventories including raw materials, work in-progress and finished goods and long term assets net of accumulated depreciation.
- The actual ROI is calculated monthly for each division and the formula is uniform across all divisions as it is centrally determined.
- In undertaking performance evaluation, emphasis is laid on trends rather than absolute goals and standards.
- The management also lays emphasis on divisions whose performance is improving or deteriorating and has set a minimum expected ROI below which the manager is required to face disciplinary action. This minimum ROI is however loosely set hence easily achievable.
- The minimum ROI is determined by applying different weights to the three investment components as follows; 20% of depreciable assets, 12% for inventories and 6% for account receivables.
- Transfer prices between divisions are negotiated between themselves.

- Other materials will have to be bought at the above price if the contract is to be undertaken.

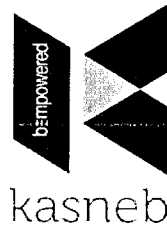
